GRADE 1-6 CHILDREN

(Children who have completed grades 1 - 6 as of June 30th)
OSC fees include a Program Fee which covers field trips, transportation & special events.

Full - Time: \$625 / month (July 1-31 / August 1-31)
Weekly: \$200 / week (Monday - Friday)
Daily: \$ 50 / day (Min. of 4 days/month must be booked)

KINDERGARTEN CHILDREN

(Kinders are classed as Kinders until their 1st day of grade 1).

Full - Time: \$200 / month \$650 - \$450 (Affordability Grant)
Program Fee: \$ 50 / month (Covers field trips, transportation & special events. This fee must be charged separately due to the Affordability Grant.)
Daily: Not available

OSC CENTRES SUMMER HOLDING FEE

If you do not require child care during July and/or August, but require it in Sept., **you must pay a Summer Holding Fee.** Without paying the holding fee, SIGIS cannot guarantee your spot in Sept.

Holding Fee: \$150 / child / month
