

We will hold our AGM and first monthly meeting of the year next Wednesday, September 25 th at 7PM in the school library.

Our executive for 2024/2025 school year will be voted in next week at our first meeting.

Our bank balance is currently \$48,464.88.

Healthy Hunger, our hot lunch program, will continue as a monthly fundraiser for us this year and Carly Haynes has graciously agreed to run the program again. Because of rec academy it'll run on Fridays this year. Carly is currently looking at dates that need to be approved by school admin before we can send out any more information, but hot lunches should start in October.

We have designated funds for the playground in the amount of \$40,055.33. Usable money in our account right now is in the amount of \$8,409.55.

FUNDRAISERS

Our first fundraiser of the year will kick off soon with Art Cards.

We will be discussing ideas for fundraising for the upcoming year next week at our monthly meeting. Last year majority of our fundraising dollars were earmarked for our new playground. Our plan for this year is to work together with the playground committee (hoping we have one) to reach our goal of \$70,000 by the end of this year. We are currently looking for company sponsorships and donations so if you know of anyone, please tell them to contact me or the school.
