7. Trustee Report (Joe Becignuel)

- They did a review online for 3 public constitutions (based on population numbers; i.e. St, Albert has \$72,000 -4 - Morinville 11,000 and 2 trustees and Legal has 1 trustee .) The idea was to reduce the trustees to 6 and have 5 in St. Albert and 1 in Morinville/Legal. It was settled on 5 for St. Albert (each trustee is responsible for 17,000, 1 for Legal and 1 for Morinville - 6500 a piece). There has not been any change in 30 years. This was passed on November 7, 2024 and it will be submitted to the minister. New nominations will be available after January 1, 2024. This needed to be done by December 31, 2024 prior to an election year (candidates need to only be Catholic). I've included further details on this below.

- The diivision office was renovated and they moved back in on November
  1, 2024 (It was an 18 month process).
- Next board meeting is November 25th in the afternoon (a mass will proceed it).

- Marueen Offenberger and Trisha Lema were awarded for their excellence as well.
- Alberta School Board Association Board of Directors Joe Becignuel has now joined this committee (this is a big deal as there aren't a lot of Catholic representation on this committee outside of Edmonton and Calgary).

-It has been going great. There are 4 new members. There have been a few classes that don't do the prayers, and so maybe there is a gentle way to talk to the teachers about this.

## 11. Major Projects Committee - Playground

- We can add to our sponsorship letter about tax donation and Canada helps. We need to get out to the businesses.

- For clarification: Families and Friends is solely responsible for fundraising and Major Projects Committee - Playground is solely responsible for planning the playground.

- Mark met with the city and the recommendation was to not break the park into two sections because of the size of it. There is a lot of patch work that has been done at our park (which is common) and it's looking more and more like both parks should be replaced.

- We need to fundraise about \$100,000 (minimum) to \$150,000. The total cost for the park will be approximately \$300,000 to \$350,000. It is important to find out exactly what the park is going to cost.

-We are hoping to have the money by March 2025 to build for summer 2026.

- The \$125,000 provincial grant is not guaranteed and we need to be aware of this.

- Some developers will come to take a look at our fall zones. We are hoping to do a park with an inclusivity design.

- To conclude, we will focus on corporate sponsorship and leave the school community for a while.

## **Trustee Report**

On behalf of the Greater St. Albert Catholic Schools' Board of Trustees, I am writing to inform you of the outcome of the Board of Trustees Electoral Ward Boundary Review. After a thoughtful review process and community engagement, the Board made its final decision at a special public board meeting held on Thursday, November 7, 2024.

### Outcome:

The Board has approved Option A as the new electoral ward structure for the Division. This decision will maintain a seven-trustee structure with:

- 5 Trustees representing Ward 1 (St. Albert)
- 2 Trustees representing Ward 2, which will now combine the current Ward 2 (Morinville) and Ward 3 (Legal).

### **Other Options Considered:**

During the review, the Board also considered other options which were not approved:

- 1. Option B: Reducing the number of trustees to 6, with:
  - 4 Trustees representing Ward 1 (St. Albert)
  - 2 Trustees representing Ward 2 (combined Morinville and Legal).
- 2. Option C: Reducing the number of trustees to 6, with:
  - 5 Trustees representing Ward 1 (St. Albert)
  - 1 Trustee representing Ward 2 (combined Morinville and Legal).
- 3. Maintaining the Status Quo: This option retained the current ward structure with 7 trustees and no changes to boundaries. It was not selected because it does not address the changing demographic realities across the Division.

The Board's decision to adopt Option A reflects a commitment to maintaining robust representation for all communities while balancing the demographic realities across the Division.

### Why Was this Review Conducted?

The Government of Alberta mandates this review every four years before an election year to ensure electoral boundaries reflect demographic and geographic changes and provide equitable representation for all communities.
